## RE: DEMAND NOTICE/NOTICE OF INTENTION TO SUE

We act on behalf of MUSISI VINCENT (hereinafter referred to as our client) on whose instructions we address you as hereunder.

Our client used your **Uber services** to move a friend in an Uber Car registration Number **UAU 396V** Toyota Probox, driven by one of your agents, a one **Belinda Ssemakula** on the 9<sup>th</sup> day of January 2018 from **Kabalagala Equity Bank to Cynibel Supermarket Kiwatule** in Kampala. Amongst others she fraudulently overcharged our client, and together with other agents insulted, threatened violence, defamed, issued death threats, violated his right to personal liberty and privacy, and further to it regarded all UBER Clientele as "fools", and further referred to our client as one that can't even afford a "bicycle".

In disregard of your professional obligation towards your customers, to provide a duty of care, safety, efficiency, convenience and affordable services, your agents acted contrary to the expectations of the general public, security organs, rules and regulations of licensing bodies, and the general laws of Uganda.

Our client was grotesquely defamed by your agents on social media platforms which injured our client's reputation by lowering him in the estimation of right thinking members of the society and causing him to be regarded with feelings of hatred, contempt and dislike.

Furthermore, your agents trespassed on our clients right to privacy and personal liberty when they added our client without his consent on a Whatsapp group called UBER UNDISPUTED 2018 for 249 UBER Agents, where our clients contact number was shared, and he was harassed, abused, threatened, intimidated, defamed, and also received death threats from your agents
